

#### Two Lodges of Perfection will host Grand Master Classes:




What is a Lodge of Perfection? A Lodge of Perfection confers the Ineffable Degrees, from the 4th to the 14th inclusive. They are called "Ineffable" because they are concerned with the ineffable or unutterable Name of God and with man's eager quest for the true Name. In these eleven degrees there is a profound unveiling of the character and purposes of God, "that high and holy One who inhabits eternity but dwells with him also that is of a contrite and humble spirit."

In formal ritual and in drama, ten of these degrees, based upon Old Testament Scripture and legends from the era of King Solomon, elaborate the teachings of Symbolic Masonry and apply them to practical situations which are faced in everyday life. The Fourteenth Degree summarizes what has been taught and is a moral and philosophical climax.

Important practical lessons are taught in the eleven Ineffable Degrees: secrecy and silence in all confidential relationships; reverence and obedience to God; faithfulness to family and country; justice tempered by mercy; universal brotherhood; honesty in business relations; forgiveness of past injustices; and perseverance in overcoming the difficulties encountered in our progress toward Perfection. The honor of Masonry is placed in the hands of those who seek Perfection in character and who reverence the Ineffable Name of God.

#### Seventh Masonic District Past Master Convocation

#### October 25, 2012:

Right Worshipful Brother Karl Douglas Akers, District Deputy Grand Master announced the Grand Master Convocation.

The convocation will be held at Orient Lodge #321 with breakfast being served at 8:00 am. The meeting will convene at 9:00. The meeting will be formally opened by Past District Deputies Grand Master. There will be no changes in the deputies from last year. Right Worshipful Brother Samuel Keith Johnson Sr. and Right Worshipful Brother Robert S. Jones will continue to serve in their capacities as District Deputies Grand Master.

R.W.B. Akers indicated District Deputies will confer the Past Master Degree on the Incoming Worshipful Masters-elect.

For purposes of proficiency the Deputies will assign incoming Worshipful Masters-elect to open a Lodge of Master Masons. This "lodge" will have the presiding secretary read "minutes" of a hypothetical meeting. These minutes will be rife with errors of protocol which the class of Masters will be asked to identify and correct. The Deputies will select a line of Worshipful Masters-elect to close the lodge of Master Masons.

Under the leadership of R.W.B. Akers, the staff of District Deputies Grand Master will present the Grand Master's program of **Most Worshipful Brother James F. Easterling Jr.** Grand Master of Masons of Ohio

The District Deputies Grand Master will outline the requirements for lodges to qualify for the 2012-2013 Grand Master's award. The Special Olympics program and the Summer Olympics games at the Ohio State University's Horseshoe Stadium will be discussed.

Introduction protocols for the upcoming inspection season will be reviewed to update the Worshipful Masters-elect on any changes.

The 2013 Grand Master Reception will be held at Grace United Methodist Church 104 South High Street in Waverly, Ohio Saturday, February 2, 2013. Social hour is slated for 6:00 pm with dinner at 7:00. Pricing for tickets to the event have yet to be established.

**2013 Grand Master Classes** at this writing are as follows:

- April 20th Ashtabula Mason Temple,
   Toledo, Dayton, and Gallipolis
- May 11th Akron, Canton Cambridge, Cincinnati, Cleveland, Columbus, Portsmouth, Steubenville, and Youngstown

The venues will be held in Scottish Rite Valleys with the 4th Degree to follow the Grand Master Class.

**Printed Inspection Schedules** will be available to all attending Worshipful Masters-elect to present to their lodge.

Note: If a Worshipful Master-elect can't attend he must attend a Past Master Convocation in another district.

#### Focus on a Past Master—Worshipful Brother William E. Landrum (1994)

Worshipful Brother Landrum announced a "Go to Church

Sunday" program for Sunday, December 4th at the Walnut Street United Methodist Church.

A Christmas Party was announced for December 23 everyone was invited to bring their children, grand-children and friends.

**December 6th** At the stated meeting of Scioto Lodge a letter was read from Robert Fetters inquiring about the cemetery plots in Grand View. It requested to what end the lodge planned to make disposition. This issue was assigned to a committee for study and recommendation.

**December 15th** A committee of Brother Michael A. Ash, Worshipful Brother Jack H. Case and Brother Alvin E. DePugh were appointed to investigate the acquisition of a sound system. Worshipful Brother William Bennett proposed the purchase of a copier for the office.

**January 3rd** Discussion focused on purchasing a VCR for use by the Chillicothe Masonic Bodies.

**February 6th** Formal discussion was introduced establishing a scholarship program. Initial discussion centered on naming the scholarship the "Luther Carter Memorial Scholarship" The concept was assigned to a committee consisting of Brother Gerald McCorkle, Worshipful Brother Harley Thomas, Worshipful Brother Don Ellis, Brother Brian Putnam, and Brother Michael A. Ash.

**February 16th** A group of Brethren, which met informally for a "coffee clutch", purchased and presented a VCR for use by the Chillicothe Masonic Bodies.

March 7th New Lexington Lodge #250 suffered a devastating fire and the call was issued to lodges for contributions of equipment. Scioto Lodge voted

to donate a slide projector with degree slides.

**March 16th** The committee on the sound system project reported to the lodge that the best pricing on a sound system was \$1, 886.11. The report was tabled at that time.

March 16 Worshipful Brother Harley Thomas chaired a committee to investigate and report on the correspondence from Robert Fetters presented to Scioto Lodge on December 6th. The committee findings are as follows:

The Request of The Arthur St. Clair Chapter of the Son of the American Revolution to use the cemetery site at Grandview for the placement of markers honoring veterans of the Revolutionary War who are buried in unmarked or unknown graves in the area. Worshipful Brother Harley Thomas moved to notify the above named group that we, upon careful consideration, regrettably do not wish to contribute the site for this purpose. Brother Marco DePugh seconded the motion and the motion carried. (file: min 03.16.92)

April 4th Discussion on the standing resolution of September 10, 1871 a motion was made to amend the original resolution by adding "Destitute Master Masons..."

A vote was taken to contribute \$100.00 to the Grand Lodge of Ohio Scholarship Fund

**April 20th** It was announced that the breakfast following attendance at Easter Sunrise Services was great success.

Established a budget item for entertainment expense of \$75.00. A similar item of discussion concerned changing the limit on refreshments for stated meetings from \$20.00 to read "reasonable amount."

**May 1st** Move to sponsor 20 Special Olympics Athletes for \$600.00

**May 18th** Committee report to adopt and establish a Scioto Lodge #6 Scholarship Fund. Report tabled until the next meeting

**June 6th** The Scholarship proposal failed 16-9; the issue was turned back to committee.
