Often a brother will ask "How can I find out my Raising date?" The answer is... Its right in your hands. On your mailing label there are a series of numbers which appear above your name. The first set of numbers (6) is your Grand Lodge number beginning with an "M". The second set of four numbers is the month and year of your birth, The next set of six numbers is the month, day, and year of your Raising. The last series of numbers of up to 4 digits reflect the bodies to which you belong: 1 (Blue Lodge), 2 (Chapter), 3 (Council) and 4 (Commandery). Have a Great Masonic Day!
