Who's Guarding the West Gate?

The above question is by no means meant as an affront to our capable Tyler Brother John W. Malone. Recently Scioto Lodge has received several application from potentially excellent candidates for membership in the fraternally. Our obligation to support the Fraternity meant more than simply paying one's dues annually or giving "lip service" as to how great an institution Masonry is. Currently to remain in "good standing" in Scioto Lodge #6 it is only necessary to do the former. There are growing concerns through-out the Brotherhood that this is an aberration to the intent and meaning of being an upright and just Mason.

How can we love and aid our Brothers if we do not know our own Brothers? How can we guard the West gate if we aren't aware of who is knocking at the door? Do we rely on the few Brothers who attend Lodge to do our work for us? I have seen applications with recommendation signatures of Brethren who haven't attended Lodge for many months, if not years. More than once I have had to look up the name of a Brother 's signature to verify that he is indeed a member of our Lodge and eligible to sign a petition for membership in Scioto 6. I simply do NOT know all of my Brother Lodge members. In a Lodge as large as ours, that is to be expected. I wish it were

not so.

However, in many Lodges to sign an application means that the signor not only recommends the candidate but also promises to attend the potential Brother's travels through the several degrees leading to Master Masonry. More observant Lodges also require that they act as a mentor to the candidate; answering questions, helping him with memory work and "being there" for him and with him in his Masonic travels. That, to me, would be ideal for the candidate and for the Lodge.

In 1805, at our Lodge's founding, a fine (the equivalent of more than a days' labor) for absence from a regularly stated meeting was levied upon every Brother unless sufficient evidence was presented before the Lodge and voted upon to waiver said fine. Our Masonic founding Fathers understood their obligations. Do we?

The future of the Lodge is shining and bright. Are you doing your part in making it so?

Memo from the Grand Master

At the 205th Annual Communication of the Grand Lodge of F. & A.M. of Ohio held October 17th & 18th, 2014 in Sharonville, Ohio legislation was submitted proposing a change to Article V of the Grand Lodge Constitution.

The proposed change: "Except for officers of the Grand Chaplain and Grand Tyler, no Brother shall be eligible to any of the foregoing Grand Lodge Offices who has not served as Master of a subordinate Lodge, and provided further that no Brother shall be eligible to be elected Grand Treasurer or Grand Secretary who shall have passed his seventy-fifth birthday.

Amended to read: The change is proposing raising the age limit from 70 to 75 years of age. In order for the question to come before the Grand Lodge at its

206th Annual Communication, this proposed change must be approved by two-thirds of the Lodges.

At a Stated Meeting of your Lodge between now and the end of April 2015, a simple majority voice vote needs to be taken approving or rejecting the discussion of this proposed change.

To be clear, an affirmative majority vote by the Lodge does NOT adopt this proposal. It merely permits the Grand Master to put the question before the delegates for discussion at the next Annual Communication.

This information is being disseminated for purposes of information. Scioto Lodge #6 will hold discussion and vote on this proposed change at the stated meeting March 19, 2015.
