Fiscal Alert for Chillicothe York Rite Bodies

A published article appeared in the January—February issue of **The Trestle Board** addressing a fiscal alert for Chillicothe Commandery #8. This alert has had an overriding impact on all Chillicothe York Rite Bodies with regard to the checks and balances for Chillicothe Chapter #4 R.A.M. and Chillicothe Council #4 Royal and Select Masons as well.

To explain the nature of the alert it is important to detail the issue of dues PLUS assessments levied on the various York Rite Bodies. To address this issue it is prudent to begin by setting forth the present ratio of dues allocation.

1) Chillicothe Chapter #4 R.A.M.:

Currently the Companions of this body pay Ten (\$10.00) dollars in dues. The Grand Chapter of Royal Arch Masons of Ohio require fees and per capita payable to them in the amount of Eight (\$8.00) dollars. Any elementary mathematician can conclude this is a serious imbalance of dispersion of funds.

2) Chillicothe Council #4 Royal and Select Masons

Similarly Companions of this Appendant Masonic Bodies has been paying Sixteen \$16.00) in dues, the Grand Council of Ohio R. & S.M. have been leveling fees and per capita in the amount of Eight (\$8.00) per member of Chillicothe Council #4 Royal and Select Masons.

3) Chillicothe Commandery #8 Knight Templar

The Explanation of current Dues were discussed in the January/February and is here revisited for your review. Current dues are \$29.00 + \$1.00 for Knight Templar Eye Foundation = \$30.00 dues. This is inclusive of the current \$19.00 assessment from the Grand Commandery that Chillicothe Commandery has been absorbing since 2013. Our assets are no longer such that we can keep paying these additional costs for our members.

Committees for the three Chillicothe York Rite Bodies have been charged by the respective presiding officers to review By-laws which govern the dues structure for each. Below are the results of these committees and their recommendations. Action will be taken to adopt these changes which are here presented pursuant to the Codes of the Grand Chapter of Royal Arch Masons of Ohio, Grand Council of Ohio R. & S.M. and Grand Commandery Knight Templar of Ohio.

These are the By-Law changes presented at the Stated Convocation of Chillicothe Chapter #4, Stated Assembly of Chillicothe Council #4 and the Stated Conclave of Chillicothe Commandery #8. Voting on these recommended changes will occur in the March Stated meetings of each of these organizations.

1. Chillicothe Chapter #4 R.A.M.

Section 7: The annual dues shall be ten (\$10.00) payable on or before the first day of June. If such dues are not paid or before June 30, notice shall be given at one by mail to each member who has not paid his dues. Failure to receive notice shall not excuse the non-payment of dues (Section 110.03 of Code may not be less than \$5.00 Section 110.02 of Code).

Fiscal Alert for Chillicothe York Rite Bodies

Chillicothe Chapter #4 R.A.M. (Continued)

Change Shall Read:

Section 7: The annual dues shall be ten (\$10.00) <u>plus any annual assessment from</u> <u>the Grand Chapter of Royal Arch Masons of Ohio</u> payable on or before the first day of June. If such dues are not paid or before June 30, notice shall be given at one by mail to each member who has not paid his dues. Failure to receive notice shall not excuse the nonpayment of dues (Section 110.03 of Code may not be less than \$5.00 Section 110.02 of Code).

2. Chillicothe Council #4 Royal and Select Masons Currently Reads:

Section 4: The annual dues to be paid by each member of this council shall be Sixteen (\$16.00), due and payable *in advance* at the first Stated Assembly in June of each year. No notice of the time of payment other than this By-Law shall be required. (Rev 02.15.05)

Change Shall Read:

Section 4: The annual dues to be paid by each member of this council shall be Sixteen (\$16.00), <u>plus any annual assessment of the Grand Council of Ohio R. & S.M.</u>, due and payable *in advance* at the first Stated Assembly in June of each year. No notice of the time of payment other than this By-Law shall be required.

3. Chillicothe Commandery #8 Knight Templar of Ohio

Currently Reads:

Article 4. Dues : The annual dues of each member shall be \$29.00 dollars, plus (\$1.00) one dollar for the Knight Templar Eye Foundation (except those who are Life Sponsors, Patrons or Associate Patrons) and shall be payable on or before May 31st of each year.

Therefore a By-Laws change is necessary to keep Chillicothe Commandery intact. Our previous dues were \$24.00 prior to the last increase when the assessment was \$5.00. We are now reverting dues back to the amount of \$24.00 but each member will now be responsible for any assessments the Grand Commandery applies to each of our members. Currently this assessment is \$20.00 (\$19.00 plus \$1.00 for Knight Templar Eye Foundation). This proposal change will make 2017 dues \$44.00 per member if no changes are made to the assessment amount by the Grand Commandery.

Change Shall Read:

Article 4. Dues : The annual dues of each member of Chillicothe Commandery No. 8 K.T. shall be \$24.00 dollars, <u>plus any annual assessments from The Grand Commandery of Ohio.</u>

Masonic Temple Association

The management of the Chillicothe Masonic Temple falls in the jurisdiction of the Masonic Temple Association. Worshipful Brother Michael A. Ash is presently serving the board as President. He submitted the following list of items that constitute just some of the updates that have been made to the building to ensure it is preserved in good order for years to come.

- New carpeting for Susie's gifts to help us in renting the space to a tenant.
- Renovations to the 3rd floor men's room
- Renovations to the 4th floor ladies and men's restrooms.
- Numerous upgrades to apartments on 2nd floor which has helped to keep them rented.
- New roof installed Thanks to Plan of Action and Milestone Committee donation of Moll Estate interest. This project was funded by this committee and cost \$40,500.00
- Ceiling and border repair in the Lobby and the Moll Dining Room due to plumbing and roof leaks
- New 10 burner cook stove and exhaust hood vent installing according to current code
- New ice machine
- Keyless entry installed in the elevator which allows access into building for members
- Security camera system—Blue Lodge paid for this item
- In the infancy of the electrical upgrade for the entire building
- Ongoing Elevator and boiler repairs and maintenance to maintain them in proper working order
- Scioto Lodge #6 underwrote the refurbishing of the Pool Table on the fourth floor at a cost of \$2,500; also many of the cues need replaced due to age and warped condition.

Our Brethren deserve to know what is transpiring. We could accomplish that and cut expenses if we send the **Trestle Board** electronically. I would propose that we try this with the next issue and include an explanation of our efforts to reduce cost and increase quality with more information and color photos. Hopefully, we could print in house for those with no email. I will be glad to help to set up a mass file list or in any way necessary. Editor's Note:

The problem with sending the **Trestle Board** electronically or by email is that attachments to emails may be difficult to open because the newsletter is drafted in Microsoft Publisher and may not be accessible for many users if they do not have the software in which to open it. Printing in house may not be cost effective due to the volume of units printed by Printex who prints 800 copies on 11 x 17, which our printer will not accommodate. The use of color to print pictures is very expensive versus black and white printing even with Printex doing the work. Additionally the cost of ink cartridges would not be cost effective. These are my views on the topic of printing alternatives.
