## Grand Master and Grand Secretary Virtual Meetings

On Thursday, May 7, 2020 the Grand Secretary of the Grand Lodge of Ohio launched two Virtual Meetings with the Lodge Secretaries throughout Ohio. The second virtual meeting was held Friday, May 8, 2020. Right Worshipful Brother William Carter, Grand Marshal of the Grand Lodge of Ohio facilitated the sessions.

Most Worshipful Brother C. Michael Watson welcomed everyone and went over the planned agenda. Most Worshipful Brother Keith W. Newton covered a number of subjects which included:

**Grand Master's Classes**—These will be rescheduled possibly in September however with changes from holding them on a district level they will be hosted by three or four lodges or perhaps on a "regional" level. Announcements will be made at a later time.

**Lodge Meetings**—are permitted and are encouraged to conduct Virtual Meeting with their members. Only lodge business matters and general information is to be performed. Currently in-person meetings have been cancelled until after May 31, 2020.

**Masonic Funeral Services**—Lodges are permitted to perform Masonic Funeral Services if requested by the family.

**Lodges are permitted to meet in July and August**—Assuming the Governor opens the State to have group meetings. Lodges that do not meet in July and August according to their By-Laws will receive a dispensation to permit Stated Meetings during these months as an opportunity to make up for the time being shut down.

**Grand Lodge Ceremonies and Grand Master Receptions**—to date 15 ceremonies, re-consecrations and 17 Grand Master Receptions have been cancelled. No decisions have been made regarding rescheduling these events.

**Grand Lodge Annual Communication**—is still scheduled for October 23, 2020 at Robert Center in Wilmington, Ohio.

**Ohio Masonic Home Day**—Scheduled for June 7, 2020 and the annual Opening Ceremonies for Special Olympics have been cancelled.

# 2020 Scioto Lodge Scholarship Recipients



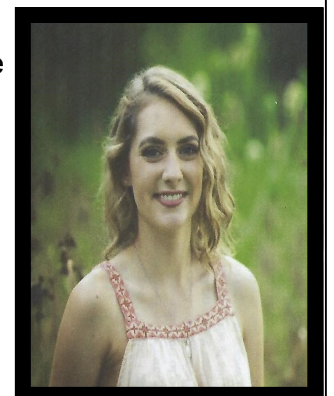
