#### Seventh Masonic District VA Representative—by William Bennett

The district meeting is slated for Saturday, May 15, 2021 at West Union Lodge #43 at 8:00 am. Its at this meeting I, as the VA Representative, seek support of the Officers of the Seventh Masonic District Association for the annual project.

I have been in contact via email with Ms. Jamie Russell, Volunteer Associate at the Veterans' Administration Hospital regarding the district's prospective 2022 project to provide assistance to both on and off campus Veterans using the services at the Veterans' Administration Hospital in Chillicothe.

In 2018 eight of the sixteen Lodges, the Eastern Star Chapter #419 in Chillicothe and some individual Brethren participated and raised \$4,250.00 for the <u>Shoes for VETS</u> which saw more than 300 pairs of shoes, house slippers and shower shoes being given to Volunteer Service for distribution.

Our <u>Sweats for VETS</u> in 2019 was well received with the assistance of Right Worshipful Brother **Charles Curt Shanks**. The efforts of all sixteen Lodge in the seventh district, the Seventh Masonic District Association and two individual participants raised \$2,560.00 providing Sweats to the Veterans.

Twelve lodges in the Seventh Masonic District participated in the **Ditty Bags4VETS** in which we provided personal hygiene supplies at the VA Bingo event in December. Right Worshipful Brother Shanks provided the Ditty Bags with the Seventh Masonic District Logo and Vets were able to select supplies for their use. Personal hygiene products in the amount of \$1,226.31 were purchased and another \$1,173.69 was provided to Volunteer Services in cash for Recreational Therapy (\$586.69) and Canteen Coupon booklets (\$587.00) were provided to the Veterans.

In 2020, with COVID-19, things were more tentative and access to being on campus became impossible. The **Help-A-VET 21** resulted in collected funds in the amount of \$1,740.00 were sent to Volunteer Services for use in providing for the Veterans. The **Help-A-Vet21** project seemed to hit a wall with only seven lodges participating plus one individual Brother.

We seem to be experiencing donor fatigue among some of our lodges which I can appreciate. However, over the past 4 years you have my sincere gratitude for all the support and realize not every project meets with the approval of everyone. Please discuss VETERANS SERVICES among your Brethren, realizing that many of your members are **VETERANS**. Perhaps consider contributing one dollar per member or at a minimum one hundred dollars to the efforts put forth on behalf of the Veterans' Administration Hospital Volunteer Service.

Now its 2021 and Bingo events along with the annual **Picnic With the Vets** are not certain at this time. The Association has not spent its usual allocation to the VA Bingo which is \$300.00 from their annual budget. Veterans' Administration Hospital Representatives that have served the district are to be commended for their work on behalf of the district.

## Oil on Canvas Restored



The Oil on Canvas displayed in the East behind the Worshipful Master has been restored at a cost of \$1,200.00. The painting was mentioned in an 1857 article in the Scioto Gazette but research has yet to be completed in an effort to uncover the source as to when the painting was presented to the lodge.

The difference is remarkable with years of dirt and other contaminates being removed.

The restoration was a very worthwhile project in cleaning up the canvas and repairing the damage from years of neglect. It hung in the William A. Best Library for years on the east wall opposite the windows on the west where sun was an major negative enemy.

The painting has been returned and replaced in the original frame and new wire material installed to secure the painting in place. David Terry Fine Art-Restoration and Conservation Service located in Columbus, Ohio performed the work.

A couple of funnies from when I was a member of Augusta Lodge No. 141, A.F.& A.M. in Maine (now part of Bethlehem Lodge No. 35 F.& A.M. (Ohio) of which I am still a member).

First, back at the turn of the last century, there used to be a small Lodge in a small town somewhere just north or Farmington, Maine. Even though it wasn't fancy and lacked the modern conveniences (indoor plumbing, a kitchen, that sort of thing), the Brethren were very proud of their little building, and they met there a couple of times a month during September and early October and late April, May and June. In the winter they met once a month on the full moon (for the extra light at night since there was no such thing as electricity yet). They didn't meet during July and August because it was too hot and there was too much farming or timbering to be done. In the cold winter months when the wind would how and the snow would pile up, the little pot bellied wood burning stove kept them warm and cozy as they conducted their monthly meetings. Now these were men who believed in and practiced the tenets and principles of Freemasonry. Occasionally, they would have a little social where they could bring their wives, but this usually was on Sunday afternoons after church. Beyond that, no women were allowed in the building!

Now there was a little old lady who lived near the Lodge hall, and she was the source of consternation among the Brethren for years. Seems that during the winter months - and in Maine that's November through April – this woman, we'll call her Mrs. Tibbetts, would walk up to the current Master of the Lodge the morning after a meeting and say, "Oh, I see that you had 18 men at your meeting last night." Sometimes the number was higher, and sometimes the number was lower, but Mrs. Tibbetts was always right. This went on for years, and drove the Brethren crazy. Every morning after a meeting the Master would dread Mrs. Tibbetts' approach because he knew what was coming..."Oh, I see you had (the correct number) men at your meeting last night." And darn it, she was right, but how did she know? Did she have a way of sneaking in the Lodge and spying on us?

Finally, as Mrs. Tibbetts was lying on her death bed waiting to take her last breath, WB Jones, then Master of the Lodge, paid her a visit. Without nary a moment's hesitation, he asked, "For all these years you've told us, without fail and without an error, how many Brethren we had attending the previous night's meeting. How did you do it? Where was your spy hole? I've got to know." Well, Mrs. Tibbets looked up at the perplexed and frustrated man and smiled. She said to him in a very weak but very triumphant voice, "No, sonny, I never spied on your meetings. But it was easy enough to tell how many of you men were there. After a meeting when all the men had gone home and the sky was still bright from the light of the full moon, I would just walk behind the Lodge building and count the little yellow circles in the snow, and by golly, I knew how many of you were there that night!" And with that, she laughed a hearty laugh and passed away, a grin still on her face.
