## ***Masonic Temple Board News***

The electrical project has been completed with all new service entering the building from the back alley and all services updated to the businesses on the first floor and the nine residential apartments on the second floor. Electrical boxes were updated in the Blue Room, Red Room, 3rd floor hallway, and the 4th floor hallway. New electrical outlets were installed strategically in areas that did not have any electrical access in the past but were needed for sweepers, etc.

The Masonic Temple Association has ordered a new steam boiler to be installed this summer to replace the current one that is only running at about 3/4 capacity. The new boiler will be able to produce more steam but will hold a smaller footprint in space needed and will be much more efficient than the current boiler.

The Chillicothe Design and Review Board voted to grant T-Mobile permission to carry out the construction of 4 small towers to be placed on the roof of the Masonic Temple Building to service the downtown and surrounding area with cellular service. We are currently waiting on T-Mobile to receive title work and this will be turned over to their legal department who will send the contact to the board for signatures. We will be collecting monthly rent from that point forward. This will not change the appearance of the building and will take up limited space on the ground floor between the Antique Emporium and the boiler room behind the building.

We are currently accepting referrals for 2 or 3 one bedroom apartments on the second floor of the Masonic Temple Building. Interested parties should contact our Building Manager WB Stephen Steele at (740) 701-1622 for further information and a personal tour.

The Masonic Temple Board meets the second Monday one month after the end of each quarter in the J.W. Best Library on the 4th floor of the Temple. The meeting months are Feb., May, Aug, and Nov. to help with any confusion. Any Master Mason in good standing is welcome and encouraged to attend.

## Masonic Summons on Membership / Attendance

When was the last time that you attended Scioto Lodge #6?  
For most Brothers, I predict the honest answer is ... "a long time ago".  
How can I be sure of this? Because very few of us attend.

Our next question is... Why are the very large majority of Brothers not coming to Lodge?  
It is not our intent to make any Brother feel uncomfortable or uneasy about not attending. But, like most other institutions, our Fraternity is experiencing low attendance. The perennial answer to this issue for most "leaders from above" has been to recruit more members. We disagree with this approach for many reasons, but mostly because it is hard to recruit good men in today's world AND we already have literally hundreds in our ranks.

You may remember, "Harmony is the strength and support of all institutions, especially this". It is difficult to achieve harmony and grow the Lodge to become better men without a mutual understanding through knowing our Brothers.  
With this in mind, WM Terrell Fairrow has appointed a committee of these Past Masters to address the situation. I use the word "situation" and not "problem" for exact reasons.  
Freemasonry, in making good men better, is based on two major concepts, freewill and accord. Each of you became a Brother through your own freewill and no-one else's.  
Freewill is defined as "the power to act without constraint, the ability to act within one's own discretion."  
Accord is defined as "to agree with, to be consistent with, to be in harmony." So mote it be.  
It is clear that most Brothers throughout our Masonic Fraternity are acting by their individual freewill and accord by not attending Lodge. We believe that the Fraternity suffers universally from this and that we know only a few of our many Brothers well.

We, as active Past Masters of Scioto Lodge #6, are asking that you seriously think about the reasons you do not attend, even infrequently or never, if not regularly.  
In the near future you will receive , in the mail and also available on our website, a survey regarding this subject. The survey will be in the form of a summons.

Our Masonic Code allows the Worshipful Master to make such a request. We all agreed "...to answer and obey all signs and summons sent to us by a Lodge...". This survey is a legal summons allowed by our Constitution which in a like manner we agreed "to abide by and conform to". As such, this summons becomes a mandate.  
If you are physically and mentally able and as a true and loyal Brother, we are asking that you honestly reflect in answering the survey's questions.

In closing, our Lodge is strong and changing for what we believe is for the better.  
Please help **YOUR** Lodge grow in strength and harmony. You can do so by simply answering the Master's summons.
